RESOLUTION OF THE HUMBOLDT COUNTY ASSOCIATION OF GOVERNMENTS
ADOPTING THE FY 2025-26 CYCLE A LOW CARBON TRANSIT OPERATIONS
PROGRAM (LCTOP) PROGRAM OF PROJECTS

WHEREAS, the Humboldt County Association of Governments (HCAOG) is an eligible project sponsor and may receive state funding from the Low Carbon Transit Operations Program (LCTOP) Public Utility Code (PUC) Section 99313 funds for Humboldt County; and

WHEREAS, the California State Controller's office notified HCAOG of \$225,020, PUC Section 99313, and \$38,194 PUC Section 99314, available LCTOP funding for Cycle A;

WHEREAS, the statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 862 (2014) named the California Department of Transportation (Caltrans) as the administrative agency, in coordination with the California Air Resources Board and the State Controller's Office, for the LCTOP; and

WHEREAS, Caltrans has developed guidelines for the purpose of administering and distributing LCTOP funds to eligible project sponsors; and

WHEREAS, the Humboldt Transit Authority is an eligible project sponsor and has the authority to also manage and administer the LCTOP funds on behalf of the City of Arcata for the Arcata & Mad River Transit, has requested \$225,020 of PUC Section 99313 and \$38,194 of PUC Section 99314 to support capital project costs associated with the adoption of Fuel Cell Electric Buses; and

NOW, THEREFORE, BE IT RESOLVED THAT:

1. HCAOG approves the total allocation request by the Humboldt Transit Authority for \$263,214 for FY 2025-26 Cycle A LCTOP PUC Section 99313 and 99314 funds;
2. The State Controller, the California Air Resources Board (CARB) and Caltrans are hereby requested to pass-through \$225,020 of HCAOG's regional share (PUC section 99313) LCTOP funds directly to Humboldt Transit Authority;
3. The Executive Director is hereby authorized to sign agreements with the Humboldt Transit Authority, Caltrans, the State Controller and other agencies as may be necessary for the transfer of \$225,020 of HCAOG's share of LCTOP funds directly to Humboldt Transit Authority.
