RESOLUTION OF THE HUMBOLDT COUNTY ASSOCIATION OF GOVERNMENTS
ADOPTING THE FY 2026-27 STATE OF GOOD REPAIR ALLOCATION

WHEREAS, Senate Bill 1, passed in 2017, named the California Department of Transportation (Caltrans) as the administrative agency for the State of Good Repair (SGR); and

WHEREAS, Caltrans has developed guidelines for the purpose of administering and distributing SGR funds to eligible project sponsors (local agencies); and

WHEREAS, the Humboldt County Association of Governments (HCAOG), in its official capacity as the designated Regional Transportation Planning Agency has roles and responsibilities set forth the State of Good Repair (SGR) Program Guidelines; and

WHEREAS, the goal of the SGR Program is to provide funding for capital assistance to rehabilitate and modernize California’s existing local transit systems; and

WHEREAS, HCAOG solicited projects for the distribution of \$278,815 of 99313 SGR revenues based on the State Controller’s Office estimate and received the following projects; and

WHEREAS, Humboldt Transit Authority assumed responsibility for Arcata & Mad River Transit System operations beginning in FY 2025-26 and therefore administer the total SGR allocation; and

WHEREAS, HCAOG is responsible for:

- Providing Caltrans an annual list of all projects proposed to be with SGR funding made available to the region per PUC 99313; and
- Receiving and allocating 99313 SGR funds to projects in the region based on local needs; and
- Receiving and sub-allocating SGR funds to the transit operators under their jurisdiction based on the amounts published by the State Controller’s Office (PUC 99314); and
- Ensuring funds are expended on SGR eligible activities; and
- Complying with all relevant federal and State laws, regulations, and policies for funding; and

NOW, THEREFORE, BE IT RESOLVED that HCAOG does hereby authorize the programming of \$319,273 to the project sponsors, in accordance with Caltrans' SGR Program Guidelines.
