Motion was made (Madrone/Jorgensen) to approve the Humboldt Bay Offshore Wind Heavy Lift Multipurpose Marine Terminal Project Notice of Preparation (NOP) Comment Letter as amended to include new language regarding Missing and Murdered Indigenous Women and encouraging that the benefits of an offshore wind industry include improved local electrical capacity and reliability.

10. HCAOG Staff and Board/PAC Member Reports

a. HCAOG Executive Director’s Report

Executive Director Burks provided the following information:

- HCAOG has been hosting quarterly RHNA meetings.
- Dan Burden will be in our area for walk audits and presentations.
- STIP draft allocations will be presented to the TAC.
- A proposal for the Safe Streets and Roads for All grant was submitted.
- It was determined that the bylaws indicate that the time of meetings is to be determined by the board so there was no need to change the bylaws to move these meetings to 4:30 p.m.
- Caltrans encroachment permits were received so work will begin soon for the call boxes on routes 96 and 36.

- Indianola Undercrossing groundbreaking and construction is underway. Caltrans will present updates to the Board as construction continues over the next three years.
- HCOAG staff attended the HTA Transit Symposium.

b. Caltrans Report

Caltrans representative Tatiana Ahlstrand presented information on the following:

- The Hwy 299/200 grade separation project is nearing completion.
- The Arcata 101 merge project to improve the on ramp from Hwy 299 to Hwy 101 will begin soon.
- Construction for the Indianola Undercrossing project is underway.
- There is a second cycle of Climate Adaptation Planning grant.
- Awards for FY 23-24 Sustainable Transportation Planning Grant will be announced in mid-August. The call for applications for the next fiscal year will be in early October with applications due in January.
- Clean CA local grant program project award notifications will go out in August and September.
- A Fernbridge stakeholder engagement will take place August 30th.
- The draft environmental document for Last Chance Grade will be available in December for review and public comment.
- The Eureka Slough project is in the environmental review phase.

c. Board/PAC Member Reports

Pac Member Arroyo provided the following updates from Humboldt Transit Authority (HTA):

- HTA held a Transit Symposium which had presenters from all over the state.
- HTA continues to struggle with driver recruitment and retention.
- Dial a Ride service will be expanded to service more riders. Updates will be provided.
- Reduced fares and contactless payments are in place.

Supervisor Madrone requested another update on the gas tax analysis from Caltrans.
