#### 11. HCAOG Staff and Board/PAC Member Reports

#### a. HCAOG Executive Director's Report

- HCAOG was awarded \$380,000 from the Safe Streets and Roads for All grant for a vision zero regional safety plan.
- HCAOG is working with Humboldt Transit Authority on a Sustainable Transportation Planning Grant application for strategic partnerships for transit.

## b. Caltrans Report - Tatiana Ahlstrand

• The Draft 2024 State Highway Operation and Protection Program (SHOPP) is open for public comment until January 19<sup>th</sup>.

• The FY 24-25 Sustainable Transportation Planning Grant cycle closes on January 18<sup>th</sup>.

## c. Board/PAC Member Reports – None

- Mayor Bergel announced that December 21<sup>st</sup> is Homeless Memorial Day. She took a moment to honor Bo Carter, a pedestrian who was killed on Broadway this year.
- Supervisor Madrone discussed the following topics:
  - The Little River Bridge project is at 30% design and local organizations are working to find funding to complete the design.
  - o Advocating for funding for repairs of Scenic Drive.
  - o The Great Redwood Trail Agency are working on alternatives for how to connect Blue Lake to Arcata.
