7. HCAOG Executive Director Report

- Updates on staffing including Associate Regional Planner, Stevie Luther's, upcoming leave of absence, and the addition of a CivicSpark fellow and on-call planner.
- HCAOG was awarded a Strategic Partnerships Transit Grant from Caltrans for the Partnering Assets and Authorities for Comprehensive Transit project (PAACT).
- HCAOG and CRTP are co-sponsoring the "Week without Driving" from September 30

 October 6.
- HCAOG will be tabling at the Tri-Counties Independent Living fair on Friday, August
- Ride Humboldt unveiling will take place at the North Country Fair on September 21 & 22.
- County of Humboldt will place a general tax for roads and transit on the upcoming ballot. HCAOG's SSTAC and TAC will be involved in some manner with the vetting process for projects. More details to come.
- SB125 funding was not cut from the state budget, but some years will be delayed.
