1. Call to Order/Introductions

Chair Katie Collender called the meeting of August 7, 2025, to order at 2:30 p.m.

2. Public Participation on Non-Agenda Items

Colin Fiske informed the committee about the upcoming Week Without Driving happening September 29 – October 5.

3. Presentations

a. Safety Camera Presentation

Currux representative, Prachi Dalal, gave a presentation on the Currux Vision traffic camera system for consideration for deployment as part of the regional Vision Zero Action Plan.

4. Consent Calendar

Motion was made (Mattson/Khatrri) to approve the following items on the consent calendar:

a. Approval of Meeting Record – June 5, 2025

b. 2025 Draft Title VI and Limited English Proficiency (LEP) Plan Update

The TAC recommended that the HCAOG Board adopt Resolution 25-19 approving the revised Title VI and LEP plan.

c. 2025 Draft Public Participation Plan (PPP) Update

The TAC recommended that the HCAOG Board adopt Resolution 25-20 approving the revised PPP.

d. Draft Revised HCAOG Transportation Development Act (TDA) Rules

The TAC recommended that the HCAOG Board adopt the revised HCAOG TDA Rules.

6. Action Items

a. FY 2025-26 Overall Work Program (OWP) and Budget Amendment #1

Motion was made (Nielsen/Mattson) to recommend that the HCAOG Board approve the FY 2025-26 OWP and Budget Amendment #1.

Motion passed with Tyler Felt abstaining.

7. Discussion Items

a. Bike and Pedestrian Level of Traffic Stress (LTS) Assessment: Public Review & Comment Period

Senior Regional Planner Oona Smith presented the Bicycle and Pedestrian LTS online interactive mapping application and requested comments by September 1, 2025. The TAC provided input on the LTS and asked that HCAOG bring back to the TAC a report on the following 1) potential revisions to the assumptions or methodology 2) potential analysis on model sensitivity 3) consultant cost implications for potential project adjustments per items 1 and 2. TAC provided additional direction to staff to ensure intent of LTS metric is clearly communicated to the public.

b. Draft State Transportation Improvement Program (STIP) Fund Estimate and Guidelines

Executive Director Brendan Byrd provided an update on the draft 2026 STIP estimate and timeline.

8. HCAOG Executive Director and Staff Reports

Executive Director Brendan Byrd discussed updates on the kickoffs of the Zero Emission Fleet Transition project and the North State Hydrogen Fueling Station Network project. There is a meeting scheduled for August 13th to review demonstration projects and input was also requested for making the choice on a safety camera for the for the Vision Zero Action Plan project. The Regional Transportation Plan timeline was also shared with the TAC.

Senior Regional Planner Oona Smith provided updates from the Statewide ATP TAC including information on quick build applications.

9. TAC Member Reports

- Catharine Crayne discussed updates on the District Transit Plan. On August 25th Caltrans will launch a survey and in September they will be doing outreach to transit operators. The draft report will be available in October.
