**1. Call to Order/Introductions**

Chair Katie Collender called the meeting of September 4, 2025, to order at 2:30 p.m.

**2. Public Participation on Non-Agenda Items**

None

**3. Presentations**

**a. City of Arcata South Arcata Multimodal Safety Improvement Plan (SAMSIP) Presentation**

City of Arcata staff and contracted consultants from GHD presented the results of the SAMSIP project.

**6. Action Items**

**a. Trail Maintenance and Funding Ad Hoc Committee Recommendations**

**Motion was made** (Khatri/Willor) to recommend that the HCAOG Board approve the formation of an Ad Hoc committee to explore possible maintenance funding strategies and rules and regulations for local non-motorized trails. Volunteers will be from City of Eureka, City of Arcata, City of Rio Dell, County of Humboldt, and Caltrans.

**Motion passed with Samuel Martinez abstaining.**

**7. Discussion Items**

**a. Regional Transportation Plan Update 2026: Discuss Plan Objectives, Update Approach and Development Schedule; Update on 2022 Safe and Sustainable Transportation Targets**

Executive Director Brendan Byrd provided an update on the 2026 RTP and Safe and Sustainable Transportation Targets (SSTT). The TAC provided input on plan objectives and potential changes to the targets and metrics of the SSTT. Specifically, TAC members addressed concerns about the use of “Crisis” and the potential to combine climate goals. Members also provided suggestions for public engagement opportunities such as MMAC, Rotary Clubs, HTA Board, and taking surveys on trails. In regard to the Safe and Sustainable Transportation Targets recommendations and suggestions included extending ZEV targets to match state mandated timelines, eliminating targets for school buses or school education, making goals consistent with CARB and HTA’s targets, rewording or replacing VMT language regarding housing development, modification of ATP goals for discretionary funding, and working with Public Health to reach Active Transportation targets.

**b. Draft State Transportation Improvement Program (STIP) Fund Estimate and Guidelines**

Executive Director Brendan Byrd provided an update on the draft 2026 STIP schedule, fund estimate and the call for projects.

**c. Training Series for Multimodal and Vibrant Neighborhoods Planning**

Senior Regional Planner Oona Smith provided information on the planning process for the training series portion of the Multimodal and Vibrant Neighborhoods Planning project. The TAC was asked to respond to an upcoming email to share interest, ideas, and requests

for the series. County of Humboldt and Humboldt Transit Authority/City of Eureka expressed interest in walkability audits.

**8. HCAOG Executive Director and Staff Reports**

Executive Director Brendan Byrd discussed CivicSpark Noah Sary's completion of service, Vision Zero Project Task Force meeting scheduling, project timeline, and an upcoming demonstration of a traffic safety camera from Currux happening on September 18<sup>th</sup> 6<sup>th</sup> and I Streets in Eureka. A questionnaire was sent out to determine which agencies are interested in demonstration projects and what resources they have available to contribute. There is also a data request for the Fleet Transition project and agencies were asked to encourage fleet managers to respond.

Catharine Crayne discussed updates regarding the Corridor Management Plan for 101 and 36, the expected date of release of the next milestone report, and status of the Clean California guidelines.
