1. Call to Order

a. Final FY 2026-27 Overall Work Program (OWP and Budget)

6. Discussion Items

a. Presentation of Level of Traffic Stress and PlaceMix Results

Senior Regional Planner Oona Smith and project consultant GHD presented the results of the PlaceMix platform as applied with the level of traffic stress assessment. The TAC discussed the possibility of being able to work with GHD in the future to utilize the software on an on-call basis, or to transfer the model to HCAOG for use by staff.

b. Draft Safe Routes to School (SR2S) Director Feasibility Study

Associate Regional Planner Stevie Luther presented an overview of the draft SR2S Director Feasibility Study and the TAC provided input.

7. HCAOG Executive Director and Staff Reports

Executive Director Brendan Byrd provided an update on the Executive Director recruitment process and requested that the TAC share the announcement in their professional networks. The Vision Zero demonstration projects are still on hold as HCAOG waits for the grant amendment to be approved by the funder. The final Regional Housing Needs Plan will go to the HCAOG Board in May.

8. TAC Member Reports

Catharine Crayne provided the following updates from Caltrans: the Urban Greening Grant Program project solicitation was opened on May 4th. There is a Caltrans Open House taking place on June 16th at the Aquatic Center.
