Staff's Recommended Action:

"I move that the PAC recommend that the HCAOG Board adopt Resolution 25-09 approving the City of Arcata's 2025 Bicycle and Pedestrian 2% allocation request in the amount of \$41,468.

Staff Summary:

Pursuant to HCAOG's adopted Rules and Regulations for the Administration of the Transportation Development Act, 2% of the available Transportation Development Act (TDA) Local Transportation Funds (LTF) is set aside for the exclusive use of projects aiding bicyclists and pedestrians.

Fifty percent of the yearly allocation was previously reserved in a set-aside fund intended for use if at any time an urgent regional priority projects come up. In calendar year 2024 the total funding requests exceeded the allocation amount available and dipped into the \$500,000 reserves leaving a reserve balance of \$432,455. A total of \$110,978 was received in 2024 and after reserving 50% into the set aside fund, the available allocation for this year is \$55,493. The balance of the reserve is \$487,948.64.

One TDA claimant requested funds this year. The total funding request is \$41,468.00 which is under the available allocation. The funding request is summarized below, and the full request is included with this staff report:
