To avoid using funds, it is important for agencies to program, monitor, and spend the oldest carryover funds first. Please update as needed.	The budget summary has been updated and carryover funds have been included. RPA carryover funds will be added during the Amendment #1 process.			
There is no work element that specifically discusses consultation with Federal Land Management Agencies (FLMAs). Please revise an existing work element to include a statement on FLMA consultation.	WE 2 has been updated to include FLMAs.
