Proposal Summary (150-word limit)

Redwood Region Audubon Society [501(c)(3) nonprofit] has an open-space easement on a parcel of land owned by the city of Eureka in Humboldt County, California. The parcel which was once known as 'Parcel 4'is now called 'Wigi Wetlands,' and includes the part of the Waterfront Trail starting at the Chevron Fuel tanks and running north along the Humboldt Bay shore and next to the Bayshore Mall. Using community volunteers, RRAS will continue our monthly maintenance and rehabilitation of Wigi Wetlands by removing invasive non-native plants and removing trash.

Over the 2022-2024 interim: we hope to complete the removal of established non-natives, continue removing new sprouts, help re-establish native plants, pick up trash, increase the number of volunteers who help, and educate the public about the trail. We will provide tools and gloves. The City of Eureka will provide wheelbarrows and dumpsters. RRAS has a part-time coordinator to recruit and organize volunteers, schedule monthly cleanups, and provide snacks on workdays.

Proposal Details (maximum two pages)

1) The location of this project is the 'Wigi Wetlands' portion of the Humboldt Bay Trail which is the portion just north of the Chevron Tanks and behind the Bayshore Mall. RRAS will continue to restore, maintain, and enhance this portion of the trail by removing invasive species, helping to re-establish native plants, cleaning up trash, and using field trips to educate the public about the trail. Clearing of large groups of Scotch broom, Himalaya berry, white sweet clover, fennel, and pampas grass has opened the view of the bay from the trail and made walking off the paved trail more accessible. Removal of new sprouts of non-natives has been easier once the main stands are gone. Native plants are returning and becoming move visible in the cleared areas. This grant proposal would cover monthly clean up days (4th Saturday of each month) from July 2022 to June -2024.

2) RRAS will:

a) Purchase snacks for each monthly cleanup and contribute in-kind labor.

b) Enhance community visibility by manually removing non-native plants. Native plants are returning to the cleared areas, creating a more natural environment. Money has also been set aside to purchase native vegetation to be reestablished along the trail, if necessary, when we have most of the non-natives removed.

c) Broaden community involvement by recruiting and coordinating monthly community volunteer cleanup days (4th Saturday of each month), which will include both restoration and clean-up activities.

d) Enhance public safety and comfort along the trail by removing trash on and near the trail. Some of this trash, for example, needles, exposed pipes, sharp pieces of metal, etc. may be dangerous to people who are on the paved trail and especially those who get into the vegetation off the paved trail.

e) Schedule fields trips along the trail to educate the public about the trail and birding opportunities.

3) Hal Genger (current Immediate Past President of RRAS) and Susan Penn (RRAS volunteer committee member) will be responsible for the work outlined for this proposal. Hal and Susan started organizing a few volunteer workdays 2017 in conjunction with the City of Eureka.

RRAS received some grant monies from "Humboldt Bay Habitat Enhancement Fund" and "Humboldt Bay Recreation Enhancement & Water Quality Fund," both funds of the Humboldt Area Foundation. We used this money to buy shovels loppers, and gloves. We hired a part-time coordinator (Jeremy Cashen) and started these regular monthly cleanups in April 2019. We received two years of grant funding from the Humboldt Bay Trail Fund in July 2020 which will end June 2022.

4) After consulting with Community Services, City of Eureka, and Volunteer Trail Stewards we set up the monthly volunteer clean up days on the 4th Saturday of each month, which fit best with other local trail cleanups. The City of Eureka has been providing wheelbarrows and dumpsters when notified and giving RRAS an overview of the Eureka City plans for the area. The overview was especially important as we learned we could not disturb one region because of ongoing monitoring by other groups.
