Thank you for the opportunity to comment on the Humboldt County Association of Governments (HCAOG) draft 2022-23 Overall Work Program (OWP). Caltrans uses this letter as an opportunity to provide recommendations for approval of work elements that contain Rural Planning Assistance (RPA) and Consolidated Planning Grant (CPG) funds. Funding for work elements in the OWP that do not contain these funds are not subject to Caltrans approval.

We thank HCAOG for developing a work program that is detailed and well-organized, and clearly articulates regional goals and priorities. We have the following comments for consideration prior to adopting the final work program:

OWP Work Elements. Work Elements (except for WE 11, RTP Implementation) have a section titled, "Previous and Ongoing Future Years' Work". This section should be split into two, individual sections to distinguish between the previously completed work (titled, Previous Work), and work that will continue (titled, Tasks) through multiple fiscal years. Each separate section should contain the information or tasks relevant for the work element. For new work elements, the Previous Work section would state, "none" or not applicable.

WE 4 – Planning and Programming State Funds. Under Task Products, item 8 appears to be incomplete (top of page 27). Please complete or remove this item, as appropriate.

WE 13 – Transit Development Plan (TDP) Update. This work element shows the TDP Update starting in FY 2022-23 with the final products carried over and delivered in FY 2023-24 (the adopted TDP). WEs completed over multiple years must provide a schedule with key milestones throughout the time of the project. Please provide additional detail for WE 13 relating to the schedule, milestones, tasks, and deliverables expected in the current fiscal year and continued into FY 2023-24.

WE 14 – Global Climate Change - Sea Level Rise. Please include a reference to climate change adaptation and resiliency in the purpose statement of this WE. Transportation infrastructure impacts from sea level rise will continue to be a key issue in Humboldt County.

Under the ongoing work item, "Research usage of E-Vehicles for impact on global climate change", please add a reference to Executive Order Number-79-20. EO-N-79-20 is likely to play a key role in the deployment of zero-emission infrastructure and the adoption of ZEVs in the region.

The planned work could benefit from additional tasks and supporting information focused on how integrating transit planning with land use can facilitate climate goals of compact development, reduced vehicle trips and travel demand, and lower GHG emissions in Humboldt County.

WE 17 – Active Transportation and Safety. In tasks and analysis, consider emphasizing the integration of public transit and active transportation modes such as bicycling and walking to maximize first-last mile connectivity for all users and meet transportation goals.

WE 20 – HCAOG Website Update. We request that HCAOG provide a schedule that includes more specific details regarding completion dates for tasks in this work element, if possible.

General Comments.

- Attached to this comment letter please find the Information Element for Humboldt County. This is a list of regional transportation planning work that is not already captured in the Overall Work Program. Beginning with the 2022-23 fiscal year, Caltrans would like to provide the Technical Advisory Committee with a mid-year review on the Caltrans-funded activities contained in the Information Element. We hope to work with HCAOG for time on the TAC agenda to provide these updates.
- As a reminder, RTPAs should help facilitate the transportation planning process with transit agencies for activities such as the Unmet Transit Needs process, short- and long-range transit plans, coordinated public transit plans, ZEV planning, proper expenditure of TDA funds, and furthering transit goals through the transportation planning process.
- In the Introduction (page 7), discussion of WE 15's evaluation of roadway pavement conditions in the region should refer to the 2022-23 fiscal year.

- In the Public Participation Process section (page 12), consider identifying any
 impacts to public outreach from the Covid-19 pandemic and strategies HCAOG is
 taking to ensure active public engagement. Update the status of the Public
 Participation Plan to reflect its adoption.
- In the Summary of Funding Needs (page 14), the OWP funding totals should be updated to reflect the 2022-23 fiscal year when that is available (use a placeholder and update the Fiscal Year).

HCAOG Response. We ask that HACOG please utilize the Caltrans comment letter, responding to the recommendations and demonstrating that they acknowledge the feedback and are incorporating them into the Final OWP. The Final OWP is due May 13, 2022. Please ensure the following are included in the final OWP Package:

- Electronically signed OWPAs
- Board Resolution
- Electronically signed Certifications and Assurances
- Appendices

As a reminder, Caltrans collects the Task Products listed in the OWP as deliverables that are funded with RPA, Sustainable Communities Competitive Grants, and RPA Discretionary grants. Please notify us when they are available.
