











Percent of children who have asked for permission to walk or bike to/from school by distance they live from school










Parents' opinions about how much their child's school encourages or discourages walking and biking to/from school

1587365	I would love to see sidewalk for bike lane put in on Grange Road. But even just a DC gravel trail would be great and less expensive to permit/build.
1587369	I would love to be able to walk with my children to/from school, but it's a long distance on a very unsafe road.
1587426	We feel our daughter is too young (6 years old) to walk or bike from our house to school. The traffic is also dangerous and more crime has been occurring recently.
