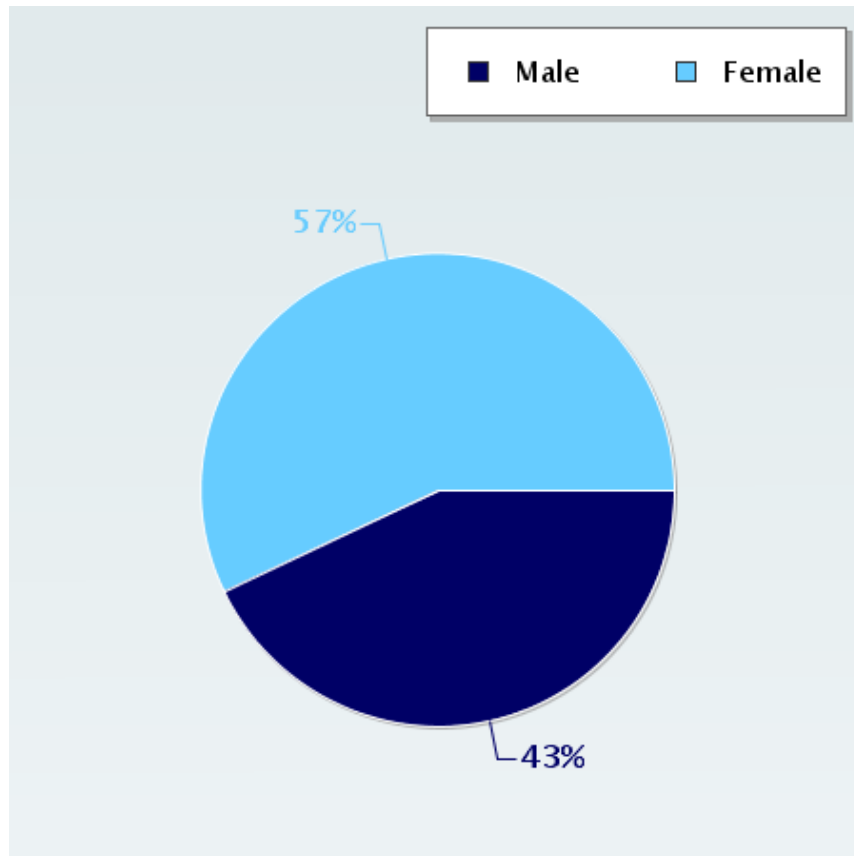

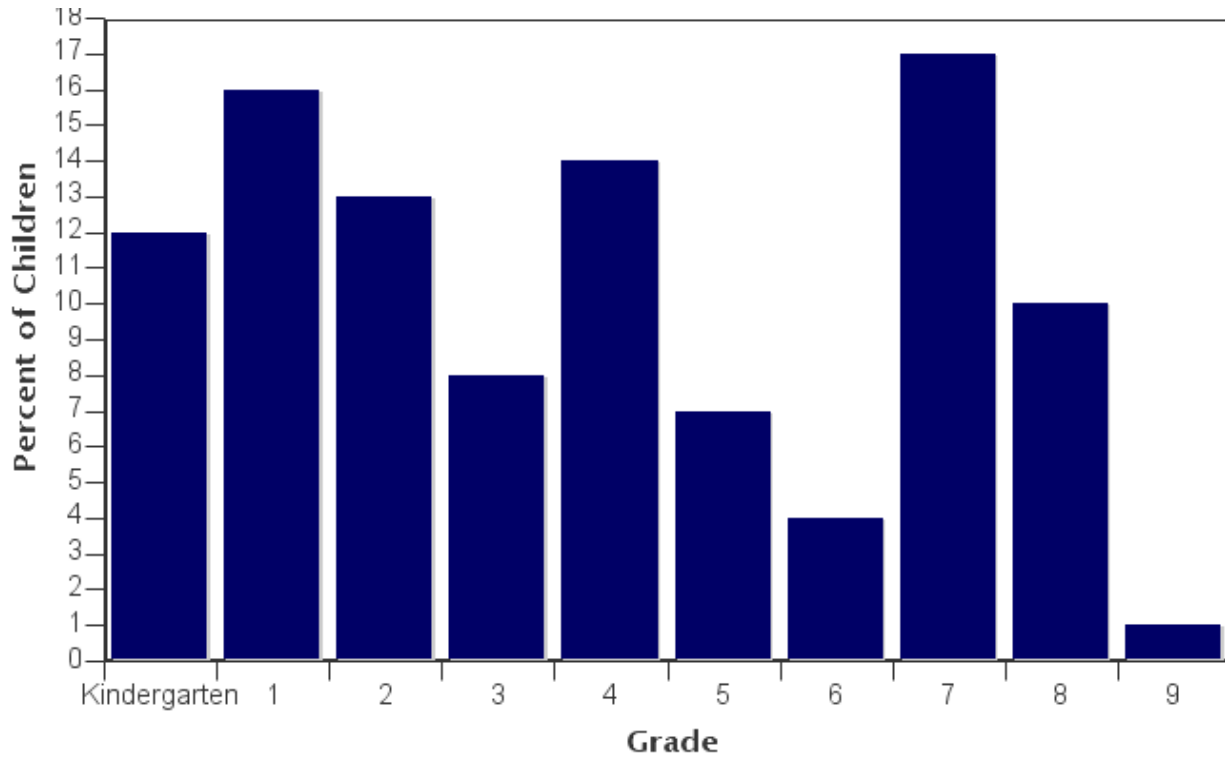

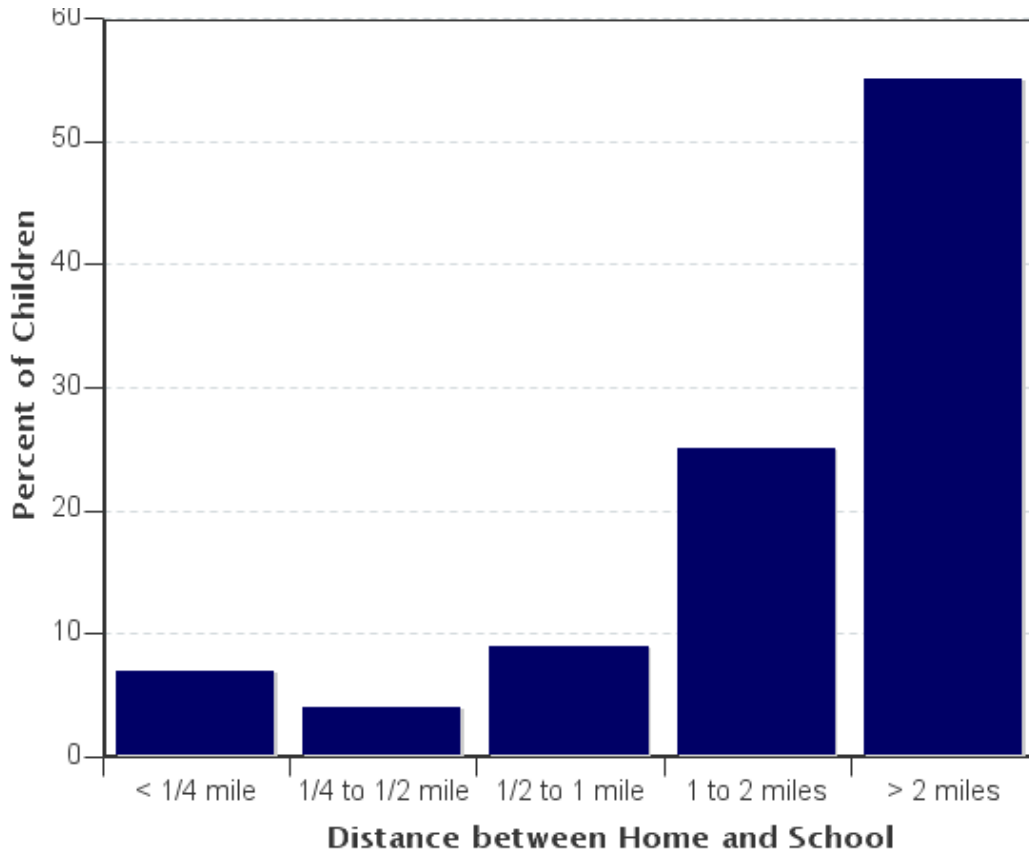

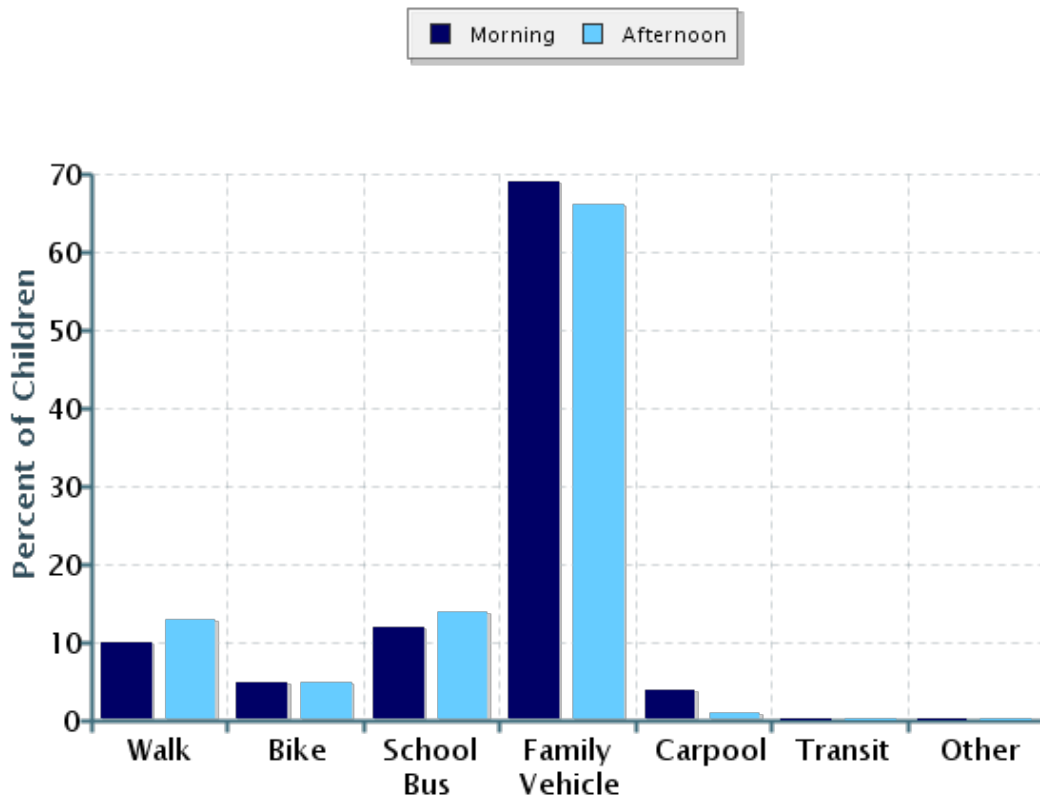

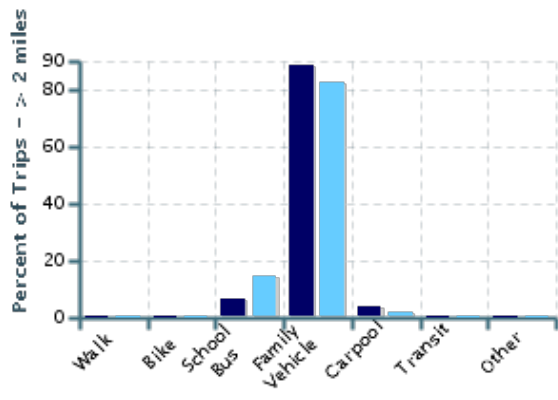

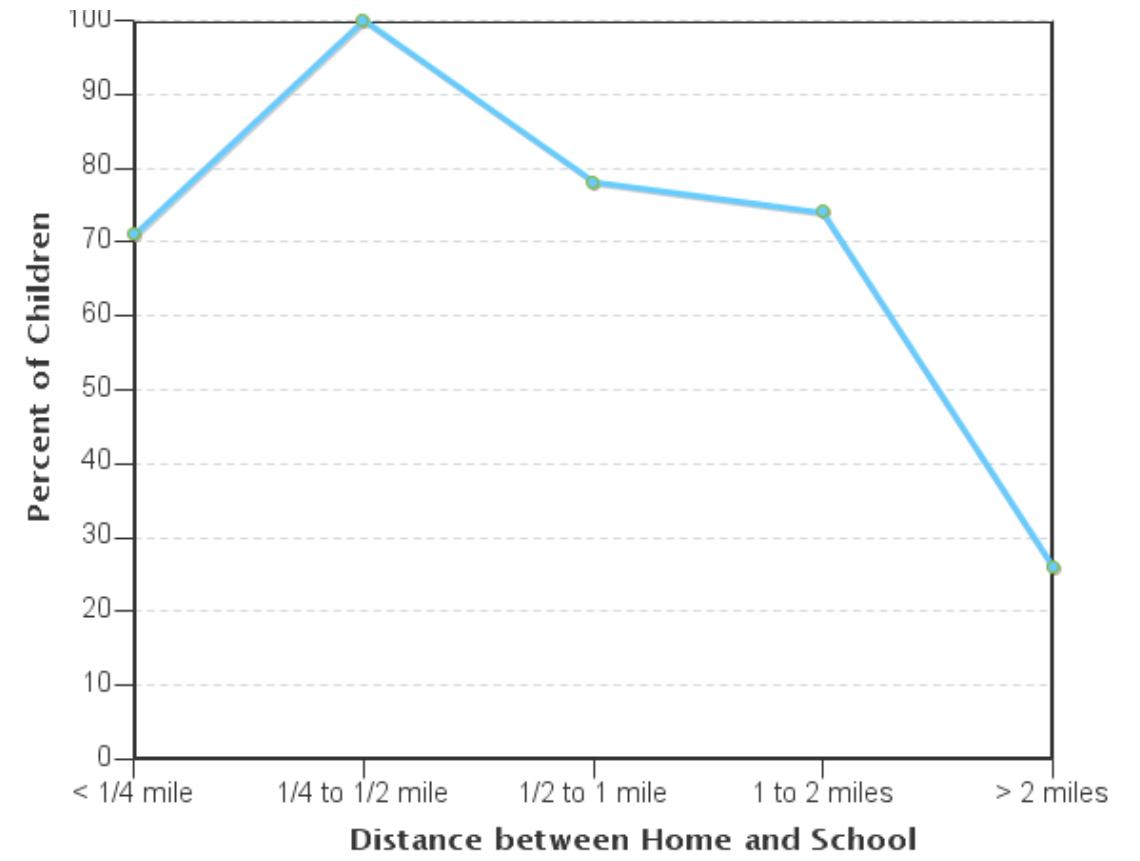

Percent of children who have asked for permission to walk or bike to/from school by distance they live from school



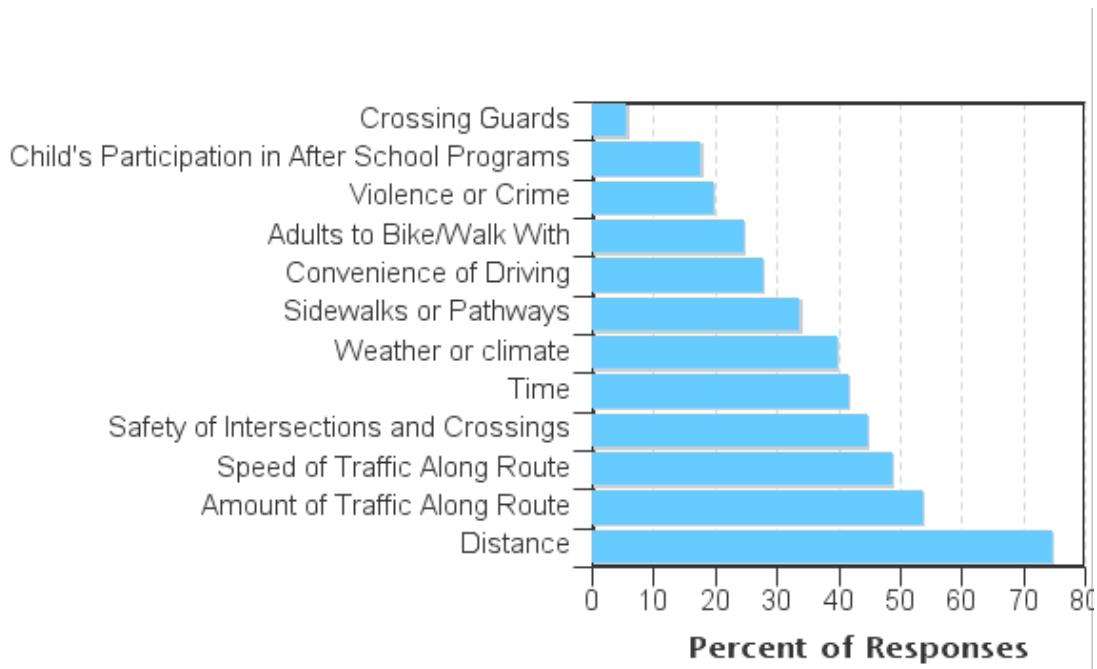

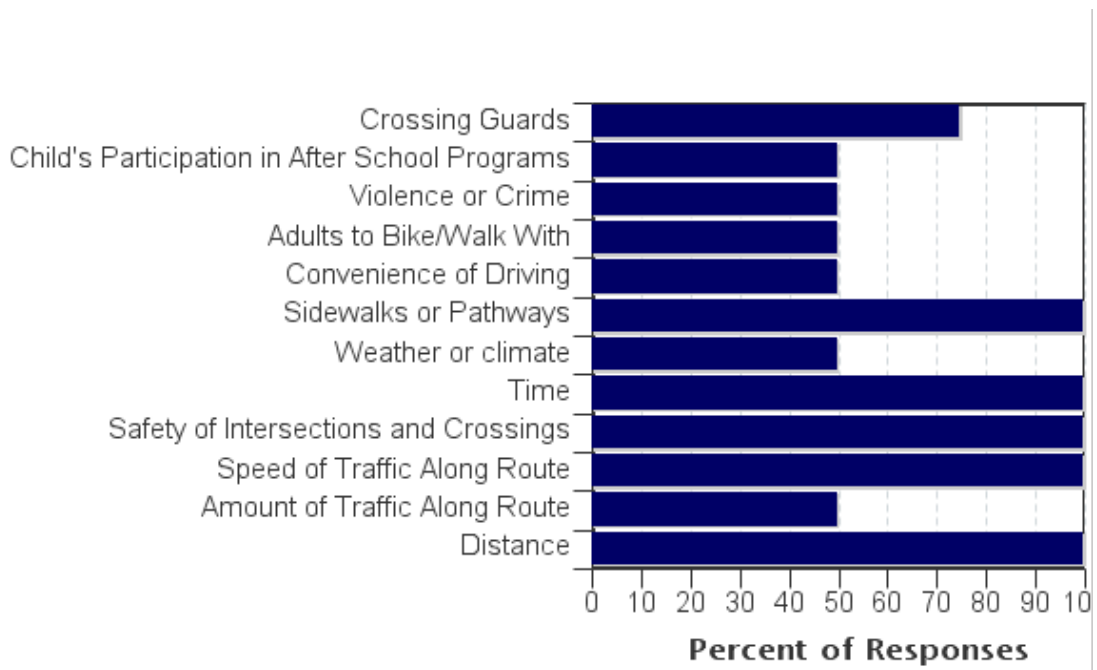

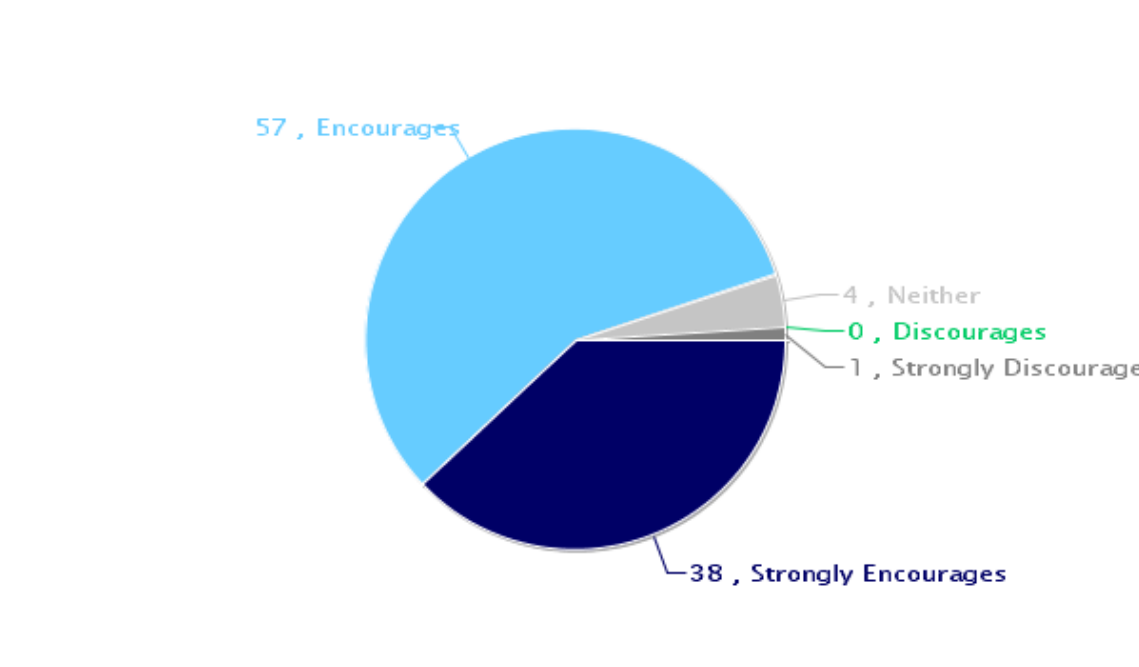

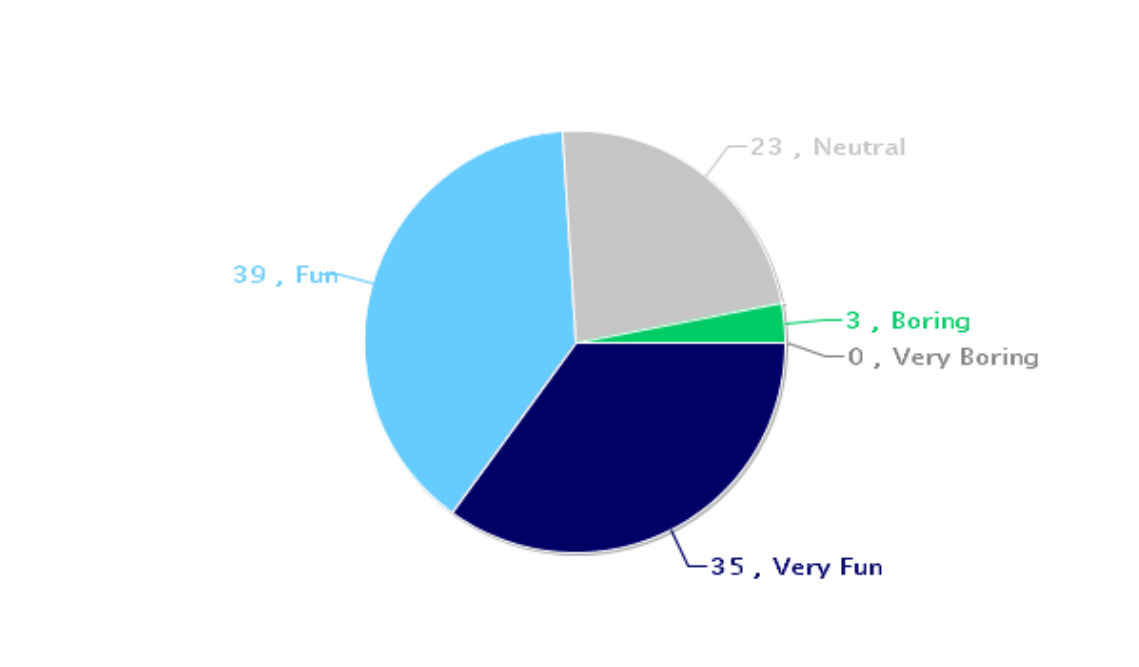

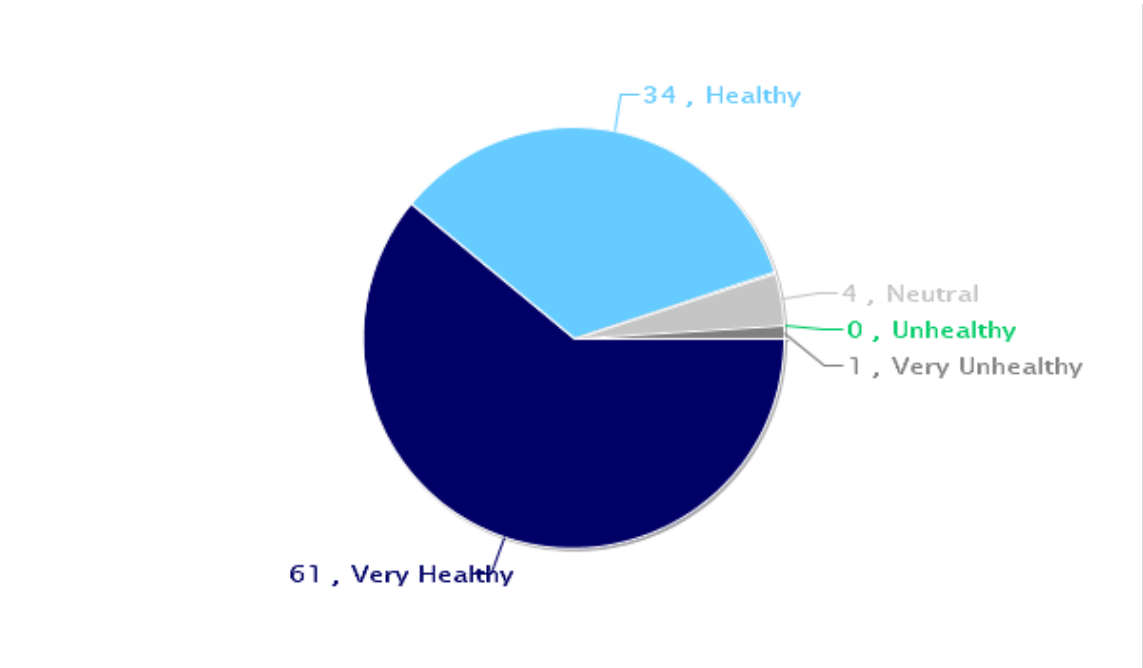
Parents' opinions about how much their child's school encourages or discourages walking and biking to/from school

1644379	We need the sidewalk on Old Arcata Road! I was almost hit while walking to a school function because there is no space to walk on the road. Put in a sidewalk!
1644386	I feel my child is responsible enough to walk to school. It's the actions of others that strongly affect my decision (driving too fast, distracted driving, etc.)
1636197	Child also bikes and walks to school.
1636217	Child also rides the school bus.
1636220	We just live too far for her to bike/walk. Sometimes she does if she's going to a friend's house.
1644342	We live close to school but there are no sidewalks, people drive fast, and it is not safe for children to walk alone. I do pick up/drop off to/from work.
1644344	I would like to see a crossing guard at golf Course Road and Old Arcata Road from 8:10 8:25 a.m.
1647657	We live out of district. If we didn't, I would fully support walking or biking to school
1644572	We love the Walk and Roll Program!
1644574	We're happy there are "Walk and Roll" days at school and the crossing guards are excellent!
1644580	If we lived closer we would definitely walk or bike to school!
1644382	My child takes the bus to Arcata High and walk from there.
1636213	Child also walks to school.
1644363	Too many drivers speed on Old Arcata Road. My children cross OAR at Anderson; usually I am with them (always in the morning) and speeding cars make this crossing very dangerous, even with radar speed signs. I would like speed bumps along this stretch.
1648525	We live in Mckinleyville.
1644578	The Walk and Rolls Days are awesome!
1644581	We ride our bike with a trailer pull behind with my son (kindergartener) and daughter (2 years old) in it. However, it does take a lot of time (adds 1-2 hr to commute). If there are any errands, I need to run out of town I drive. Also if we are running short on time. The trailer is also getting small for both kids. Once our son gets bigger I would feel comfortable with him riding next to us.
1644596	Most days I walk my kids to school and let them walk home (2nd grader, 7th grader). My biggest concern is that they have to cross Old Arcata Road @ Anderson where visibility is low and vehicles speed even though their speed is posted by radar. I would like more speed bumps on Old Arcata Road.
1636231	Child also gets to school by a family vehicle.
1644347	We live far enough away that she will be unable to complete the entire trip. We would have to drop her off.

1636193	Child bikes to school in spring and summer.
1636196	Our oath to school is dangerous. The bus takes way too long.
