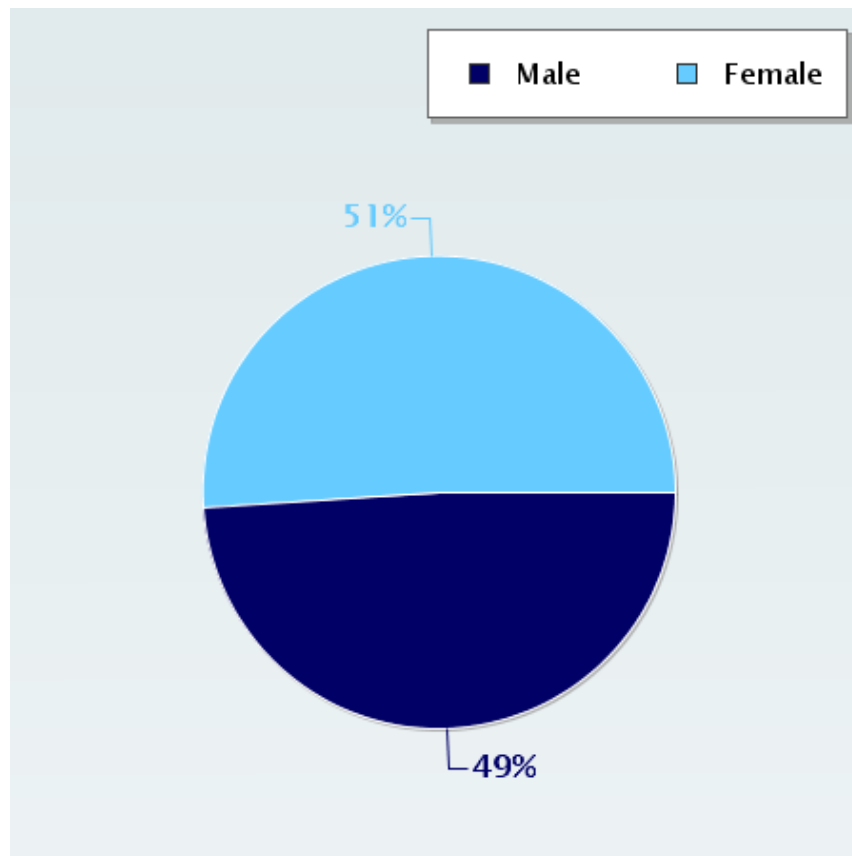

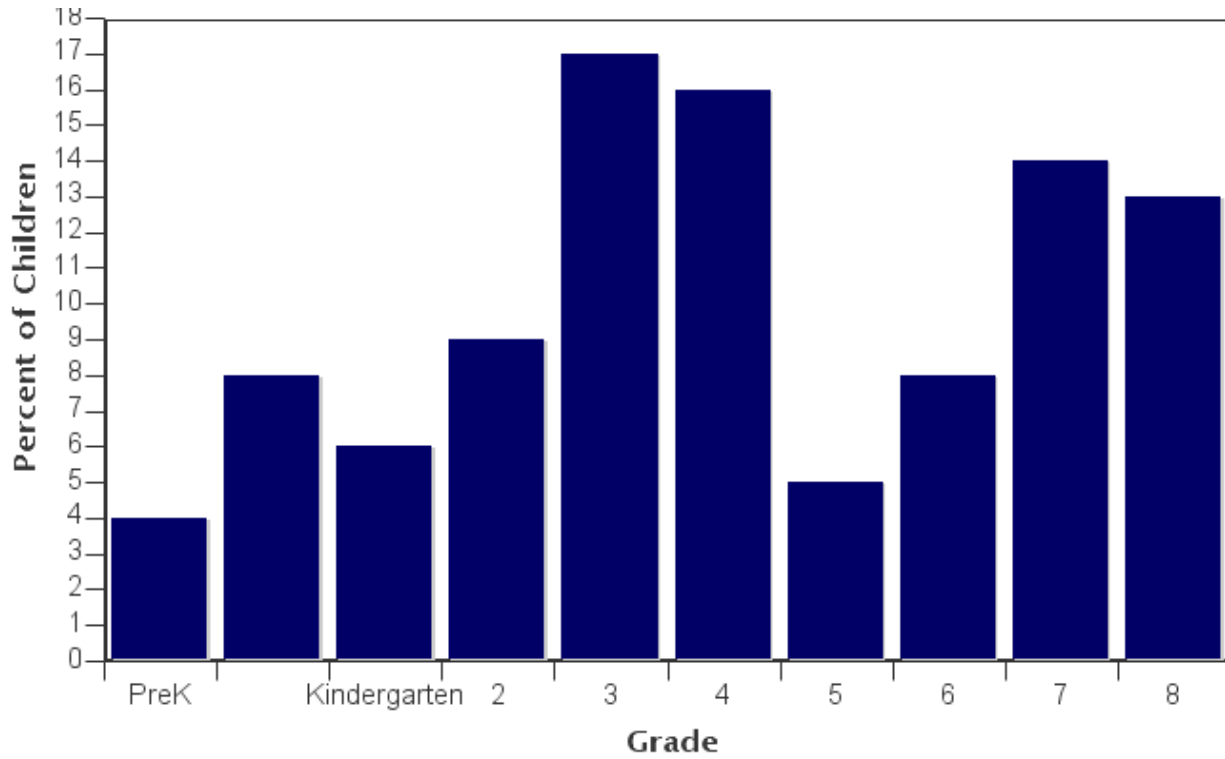

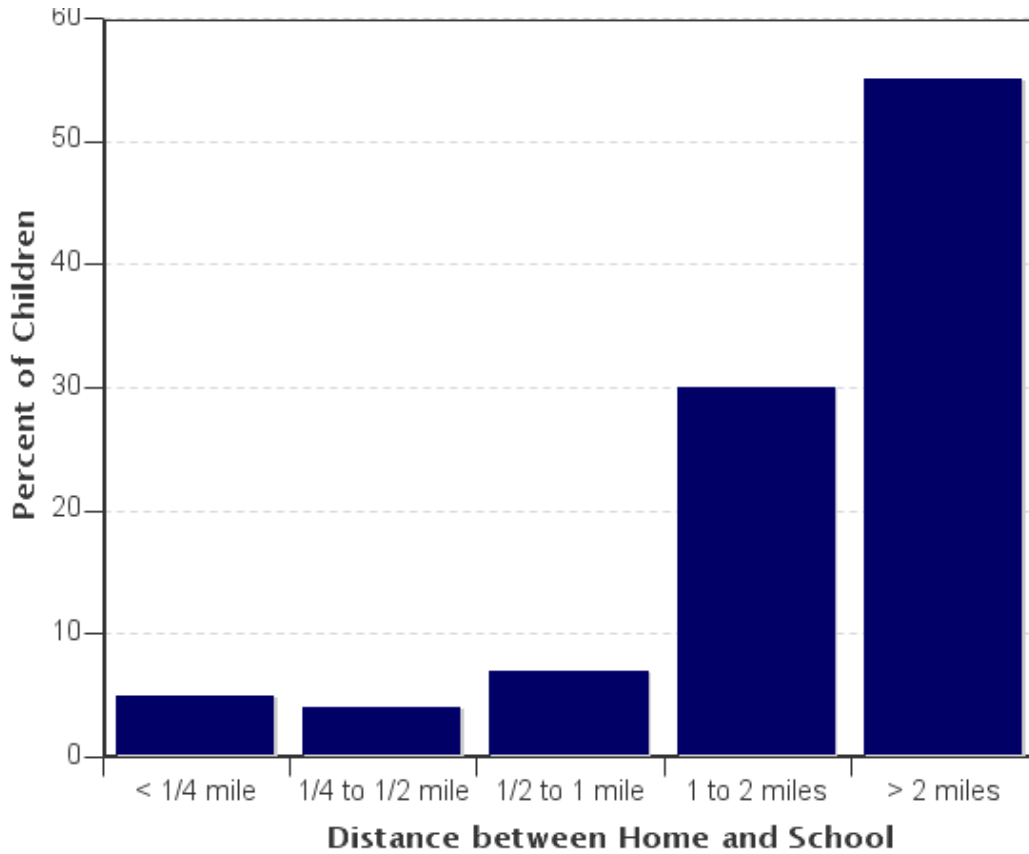

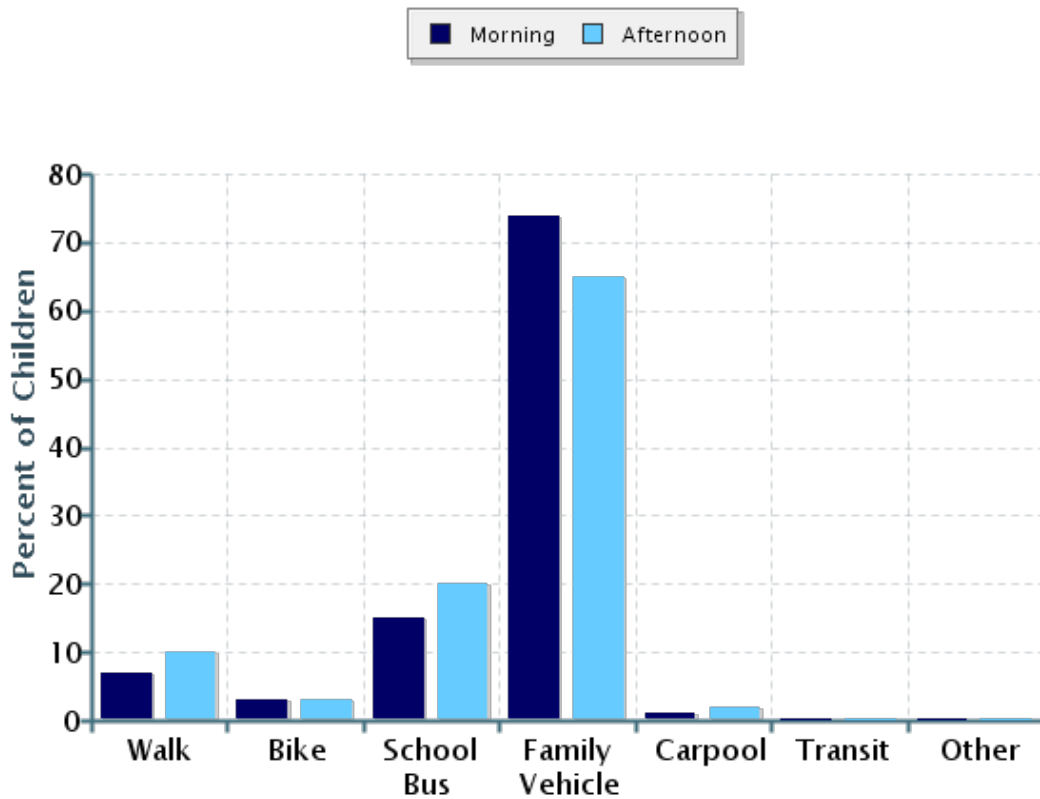

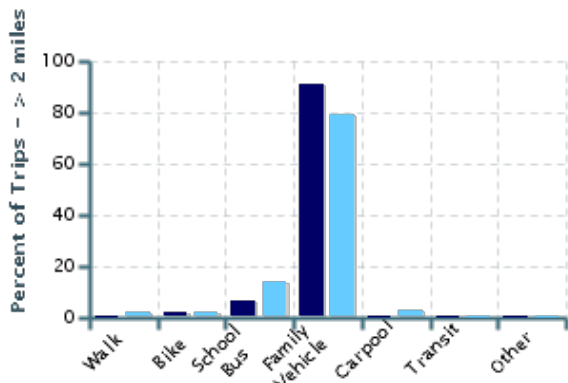

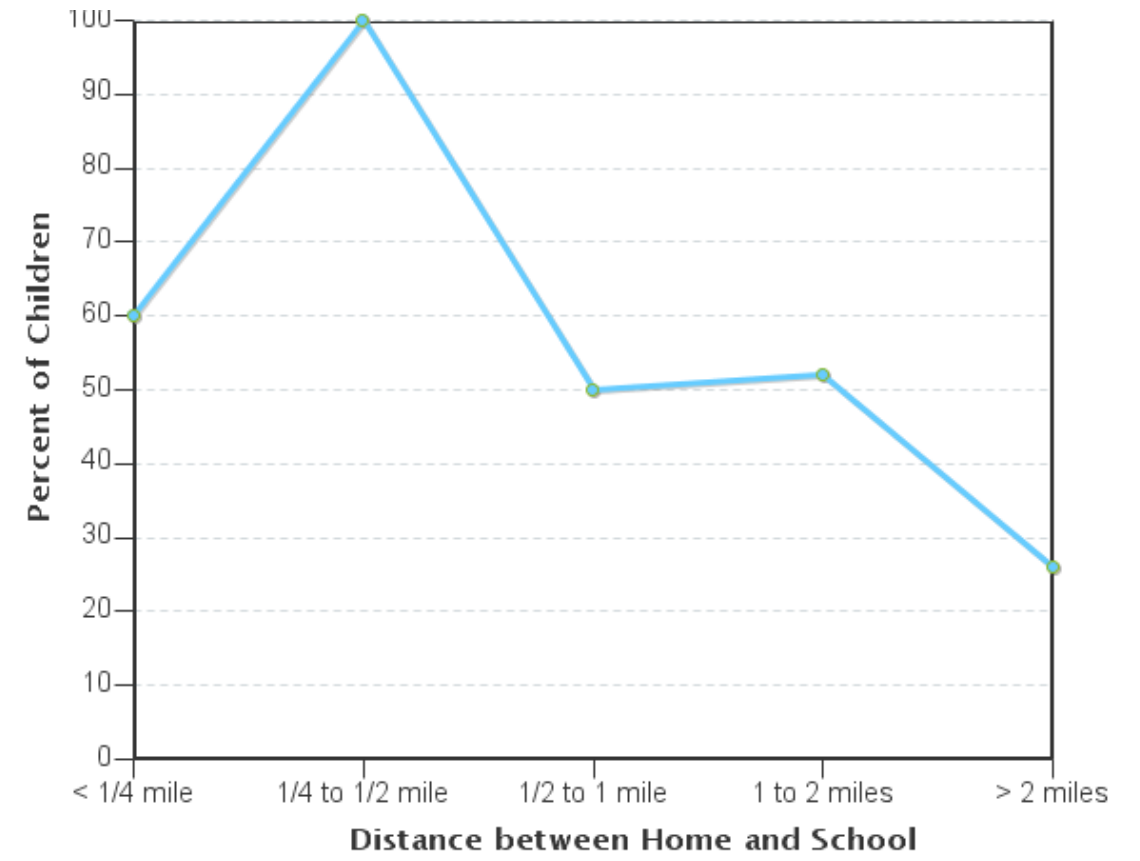

Percent of children who have asked for permission to walk or bike to/from school by distance they live from school

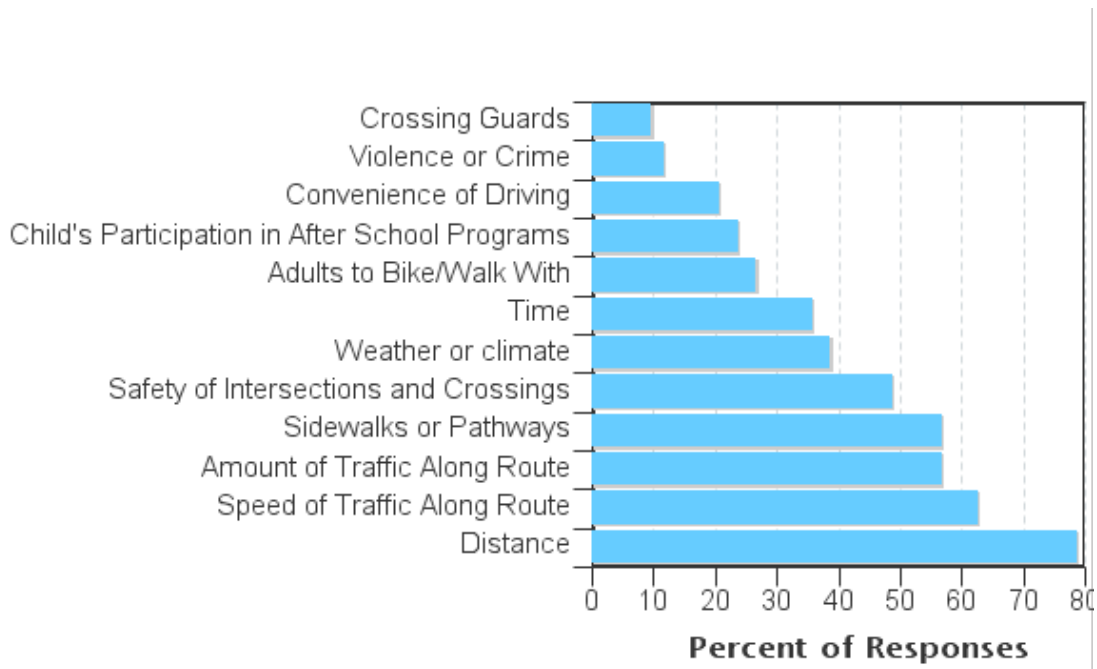

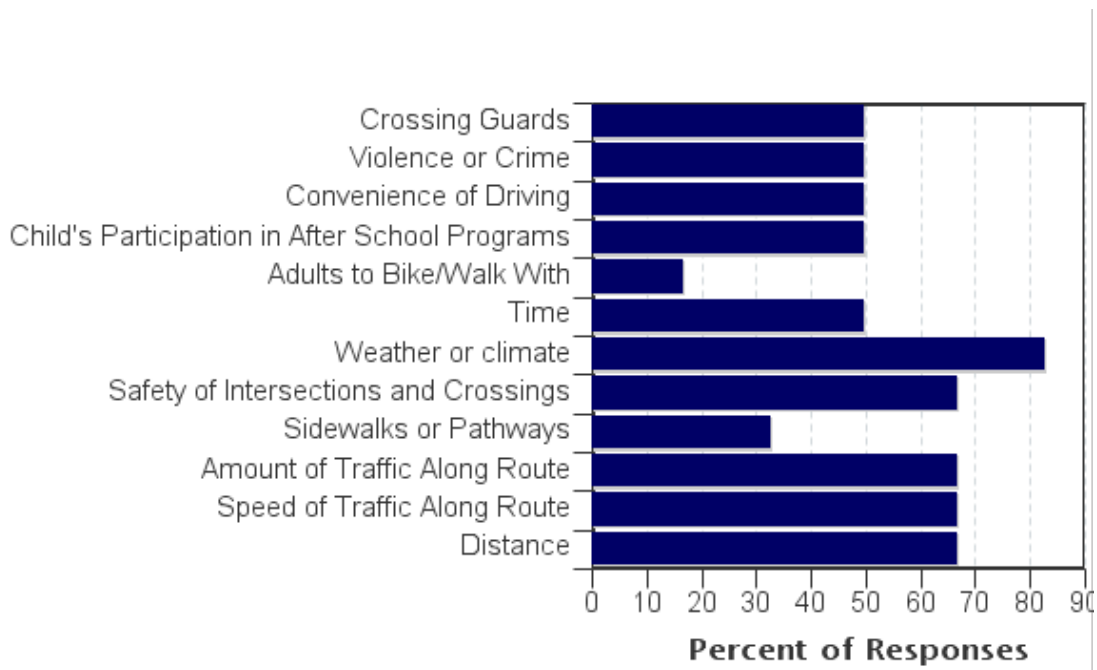

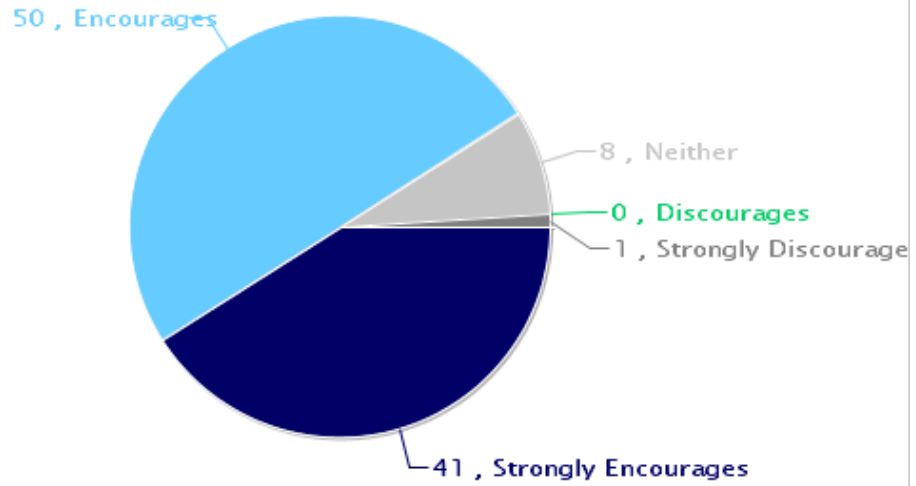

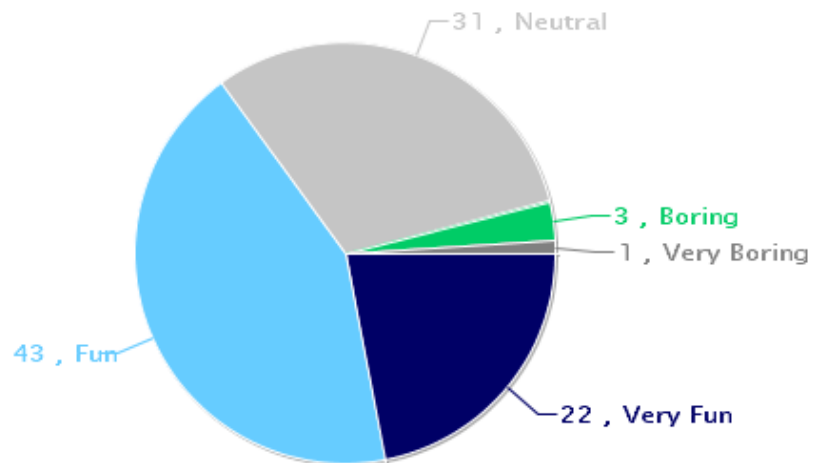

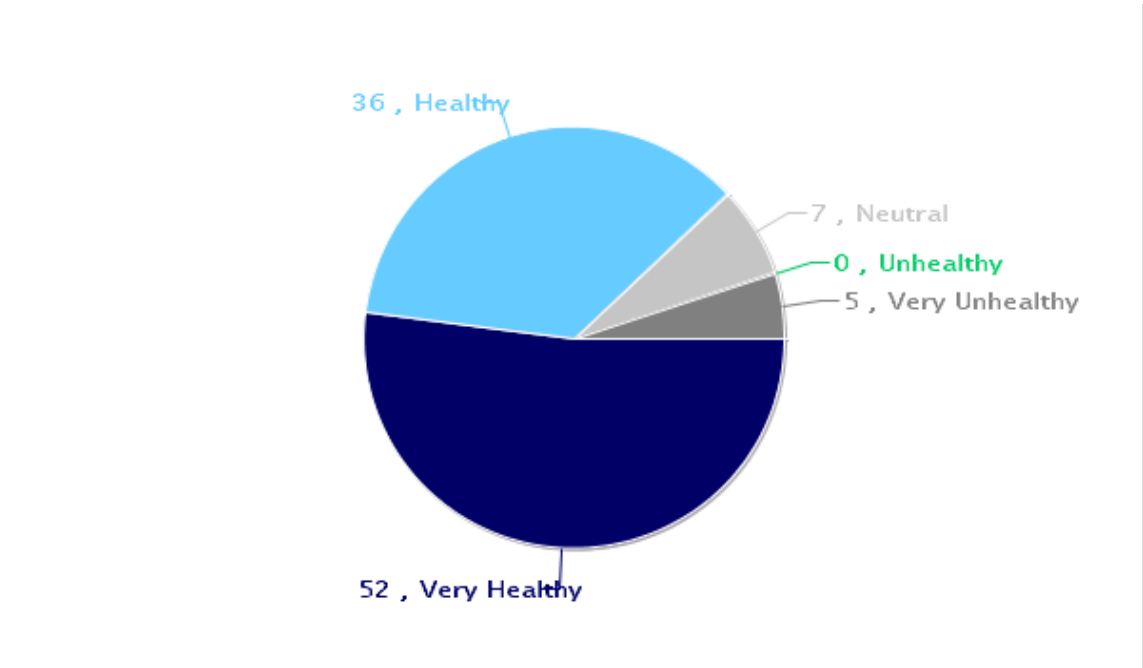
Parents' opinions about how much their child's school encourages or discourages walking and biking to/from school

1586650	Walk and Roll program is a great thing to encourage kids and adults to move their bodies to school once a month.
1586682	We live in another town. It would be impossible to walk to school.
1586694	A bike path on Jacoby Creek Road would be GREAT! Please maintain bus service, we depend on it.
1587053	She participates sometimes in walk and run day. She really enjoys that.
1586646	Answer to #9 may be different if there was an option for walking/biking with other children and no adult.
1586676	We love riding our bikes! As soon as my son is mature enough to be smart on his bike alone in traffic, he'll be riding to school.
1586678	The Arcata Road is unsafe for biking with high speed limit and rushing parents. It is a risk for anybody walking on it.
1586706	Fickle Hill Road has no shoulders or sidewalks - not very safe for pedestrians of any age!
1586642	My daughter is in TK and is barely 5 years old. We live four miles away from JCS.
1586645	She's a kindergartner so she's too young to consider. Jacoby Creek road has no shoulder/sidewalk and people can not seem to drive the speed limit.
1586660	People drive too fast on this road. It's not safe. We do walk to school on occasion, and take the school bus at least once a week. But this portion of Old Arcata Road is not safe for little kids. Too much traffic, no sidewalk, and way way too many people on their cell phones while driving past the school, including parents/staff/teachers! The school needs a no cell phone on OAR campaign. We also need status updates from City of Arcata on proposed safety improvements.

1586936	More bike/walk to school day.
1586922	Biking on Fickle Hill Road is very dangerous. If we lived on city streets, he would walk/ride to school.
1586668	Traffic too fast and too busy to feel comfortable letting kids go without adult.
1586640	I really wish we had safer walk ways in our neighborhood, e.g. sidewalks.
1587055	We live too far away. I like to see my kids off to school. I would probably (if we lived closer) walk with them if we walked.
