WHEREAS, Exhibit A - *Salary Range Schedule* listing HCAOG's full time employees is included as part of the FY 2024-25 adopted budget; and

WHEREAS, the Humboldt County Association of Governments and the State of California have entered into a Memorandum of Understanding establishing relationships for performing comprehensive transportation planning; and

WHEREAS, the State and the Humboldt County Association of Governments do mutually desire to cooperatively and jointly participate in the performance of the comprehensive transportation planning process.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Association of Governments does hereby adopt the Humboldt County Association of Governments FY 2024-25 Overall Work Program & Budget; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Association's Executive Director is authorized to execute fund transfer agreements pursuant to the planning and administrative tasks outlined in the FY 2024-25 Overall Work Program including State Regional Planning Assistance; Planning, Programming and Monitoring; and State Planning Research funds, and Partnership Planning funds.
