


Sex of children for parents that provided information









Percent of children who have asked for permission to walk or bike to/from school by distance













1688912	Westhaven is too far to walk or bike on a regular basis.
1690310	The intersections around the freeway on/off ramps make me SO nervous. Also the not posted speed limit and no sidewalks on Frontage Road.
