



Grade levels of children represented in survey







Typical mode of arrival at and departure from school
















Parents' opinions about how much their child's school encourages or discourages walking and biking to/from school

SurveyID	Comment
1690952	We trust our child to follow the route, watch for obstacles, and get to school - don't feel comfortable with other factors. Due to nature of our work, vehicle pickup is necessary to meet after school parameters.
1690908	I plan on getting pedal-assist bicycle once the Humboldt Bay trail is complete to take my daughter and myself from Myrtletown into Arcata for school/work on days without weather or sunlight limitations.
1690913	The new project to provide pedestrian access from Valley East to the Arcata Center will hopefully improve our ability to walk and bike to school.
1690917	Old Arcata road is not very safe. Jacoby Creek Road is very unsafe as there is no shoulder and some vehicles will cross over the dotted yellow to allow for room.
1690935	The route to school is mostly downhill; uphill on the way back. Sidewalks are incomplete. No shoulder, bike lane, or other safe walking/biking paths. The hill could be overcome if the route were safer.
1690937	In order for our child to walk or bike to school without an adult we would prefer that she do so with at least one other child her age or older.
1690943	Biggest concern is distracted drivers; too many people on their phones.
1690945	Other siblings is reason for not walking or biking.
1690947	I find many sktechy people hanging around the Healthsport/Community Center area. We also pass through downtown, which has a lot of traffice after school. These two things are delaying the age I would have my child bike without me. She would probably bike every day if I let her go without me - I can only bike 3 drop offs and 1-2 pick ups.
1690951	We live in another town and it would take more than an hour to bike from our house currently. If we lived closer, we would love to do it!
1690953	Jacoby Creek Road has no shoulder and people drive very fast. O.A.R. is better but the JCS traffic can be scary for bicyclists. Also there are a lot of texting drivers near JCS after dropoff - we would bike every day except when it's dumping if two roads were safe/protected for cyclists.
1690962	Our family lives at the top of a very steep hill, which makes biking hard.
1690964	Need safe bike storage. Need bike paths from McKinleyville.
1690911	Too steep!
1690918	We live a safe 1/4 mile walk from Dows Prairie Elementary but value quality of education over ease of commute. But it would be awesome if our kids could walk/bike to school.
1690919	It is difficult and scary to ride around the round-a-bouts as there isn't a bike lane and many drivers don't yield to bikes in the same way they yield to cars (same road/same rules). Also, leaving the school on a bike is challenging as there isn't a painted bike lane and almost no one drives the posted speed limit.
1690928	We do ride bikes to school sometimes, but because I have to get to Eureka for work by 8:30, we usually do not have enough time to bike.
1690932	We live in a rural community and the distance from home to school is large. We do not attend our neighborhood school, but even if we did, our neighborhood school is over 2 miles from our home.
1690938	Too steep
1690957	When I was in Jr HS, one of my best friends was hit by a drunk driver and died. He was on a skateboard in a crosswalk. I was deeply affected by this.
1690941	Walking is not an option - too far. Biking is too far and busy road.
1690936	We live in Blue Lake and my kids attend school in Arcata. It sure would be great if the Annie & Mary trail was completed before they completed school! It's far, but I could imagine us riding it a couple times a month to school.
1690942	We live in McKinleyville and go to school in Arcata, so biking and walking is not possible at this time. I'm a supporter of walking and bike around McKinleyville.
